Business Manager Dennis-Murphy reported that it was for the Read Plus Grant. The initial grant was for \$18,000 where we received half and would have to pay the other half. We will pay \$9000 of it, which comes out of Title money.

Secretary/Treasurer Weinrich asked what the difference between professional development and improvement of instruction was. Business Manager Dennis-Murphy said that she believes that improvement of instruction is for the students and professional development is supplies for the teachers. Superintendent Stannard explained that one occurs inside the classroom while the other does not. He explained that the CDE will pay for professional development, while they will not pay for improvement of instruction.
