#### **4.1 Legislative Update**

- Superintendent Fraley gave an update on Proposition LL & MM from the election. Both were passed through the State of Colorado to help fund Healthy School Meals for All. All students receive free breakfast and lunch at all schools statewide.
- The state released its preliminary budget for next year, which includes a proposed increase in per pupil funding for the next two fiscal years. The proposal also shifts to a three year average for funding, which is an improvement over the previously considered one or two year averages.

#### **4.2 Academic Progress Update**

- Superintendent Fraley shared a summary from the survey that he had done. We'll look more into this at the Board retreat in January.
- Shared the themes and priorities with staff and teachers today and received some good input.
- Also discussed reading and writing focus with teachers and taking care of each other with this time of year being stressful for staff and parents with the holidays, illnesses, and conferences.
