**9.4 Mill Levy Certification**

- President Brown stated that in compliance with Colorado Revised Statute 22-40-102(6), this is to certify that the Yuma 1 Board of Education met in a business session on December 01, 2025, and took action, recorded on the official minutes thereof, to establish the total Yuma 1 mill levy for property tax year 2025 (to be collected in 2026) at: 39.286 mils, the millage total is based on a net assessed value of: \$161,479,660.
- Superintendent Fraley gave a summary of the Mill Levy and the Bond Redemption. The General Fund Mill is set at 30.792 for this year with the Bond Redemption Fund Mill set at 8.494, total Mill Levy for this year is 39.286.

Motion by Noble, seconded by Deering, to approve the Mill Levy Certification.
